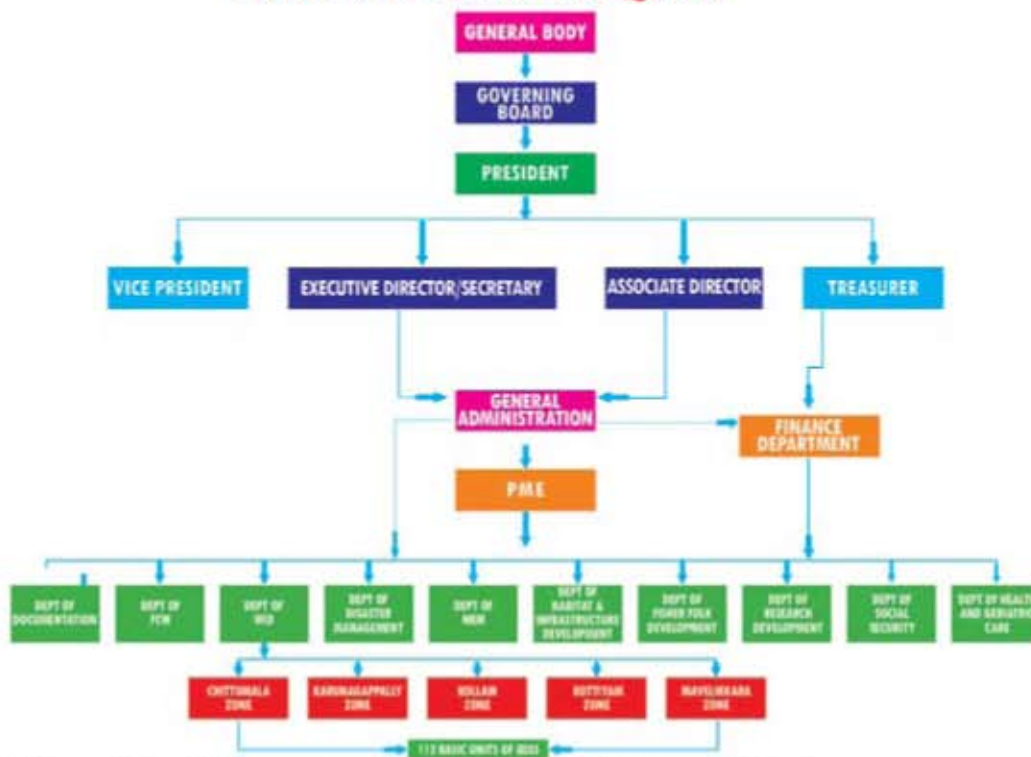

2008

### ASHAKIRANAM

Ashakiranam was started in the month of November, 2015 with the blessings of Rt. Rev. Dr. Stanley Roman, Bishop of Quilon, Adv. Rajendra Babu, Mayor of Kollam and Mrs. Vijaya Francis, Deputy Mayor of Kollam Corporation at QSSS Hall. Caritas India is the funding agent of this project.

‘Towards creating awareness about cancer, detection and support to the deprived’.

#### OBJECTIVES:

- ♦ Baseline survey to analyse the health situation
- ♦ Detection camps and awareness programmes
- ♦ Monetary support for the deserving client and his/her guardian
- ♦ Counselling and guidance support through experts
- ♦ Palliative care for the most disadvantaged clients
- ♦ Promotion of healthy food habits and lifestyle
- ♦ Volunteers as ambassadors of this programme
- ♦ QSSS as Help & Support desk for the clients

### ASAKIRANAM AMBULANCE SERVICE

Kerala State Financial Enterprises (KSFE) under their CSR Scheme donated an Ambulance to Quilon Social Service Society (QSSS) for the benefit of deserving cancer/ dialysis patients to travel from Kollam to Regional Cancer Centre (RCC), or Medical College, Trivandrum for treatment.



## SANTHWANA

Santhwana focuses on providing relief from the symptoms of serious illness and stress due to bed-ridden condition. The goal is to improve quality of life and develop positive feelings in patient's mind towards the end of their life and show solidarity to the client's family. This service is available to all age groups people with illness at any stage. Palliative care integrates psychological and spiritual aspects with the support services to the patients.

It also ensures support system to help the family to cope-up with the patient's illness and the situation of bereavement, if it arises. They help the patients by cleaning and dressing their wounds, changing catheters, giving bladder wash, testing blood pressure and sugar levels and providing counseling depending upon the need of each patient and the family members.

## SAAHYAM

This is a QSSS initiative for the paraplegic clients facing problems of dependency, low self-esteem and loneliness. The main aim is to empower them to become self-reliant. Through the project QSSS aspires to rehabilitate those people who are affected by complete paralysis of the lower half of their body including both legs.

Currently, this project employs ten members who hail from nearby places of Kollam Corporation and have their own vehicles to travel. QSSS has provided them a wheel chair for their accessibility to move around with QSSS.



- ♦ The aim of the project is the rehabilitation of paraplegic people in the district
- ♦ Vocational training is occasionally conducted for paraplegic clients in manufacturing soap, soap powder, phenyl solution, dish washing liquids and liquid blue. The products are marketed with the brand name "PALLIUM".





## DEPARTMENT OF FAMILY AND CHILD WELFARE

### SAVE A FAMILY PLAN (SAFP)

SAFP was started as a charitable society, and it was founded by Msgr. Augustine Kandathil in 1965.

Currently we have 320 families who receive our help. They get Rs. 900 per month and some families get special amount as a gift. The amount they get is utilized for doing different IGP activities, like fishing, fish vending, cow rearing, goat rearing, poultry, tailoring, carpet making, making bakery items, candle making, readymade garments business, kite business, flower making and pickle & curry powder making etc.

### Capacity Building Programme

The programmes of Capacity Building were conducted to increase the capability and knowledge of the FDP families. Those programmes were carried out by coordinator and animator.

### EDP Training

EDP trainings were conducted for the better implementation of the Income Generation Programme. They also had yearly gathering which helped them to have good relationship and to develop their talents. The SAFP conducted training for the coordinator and animators to develop and increase their skill and competency of staff.

### Golden Jubilee Celebrations and Annual Gathering Of Save A Family Plan

The Golden Jubilee celebrations and annual gathering of Save A Family Plan were conducted in the Holy Cross Millennium hall on May 5<sup>th</sup> 2015 at 10.30 am. The Programme was organized by the SAFP staff members of Quilon Social Service Society.

### Income Generation Programme

The Save A Family Plan families strictly follow the Income generation programmes as it gives a source of income for the families. The purpose of fund utilization is to carry on the income Generation Programme in order to have better living conditions and to increase their in-





come to meet the needs and demands of the family.

### **Housing**

Many of our beneficiaries still live in small huts. As a result of QSSS's constant intervention and lobbying with the Panchayat and Government, 21 families from different centers, of our Diocese received housing finance from government and also from local resources.

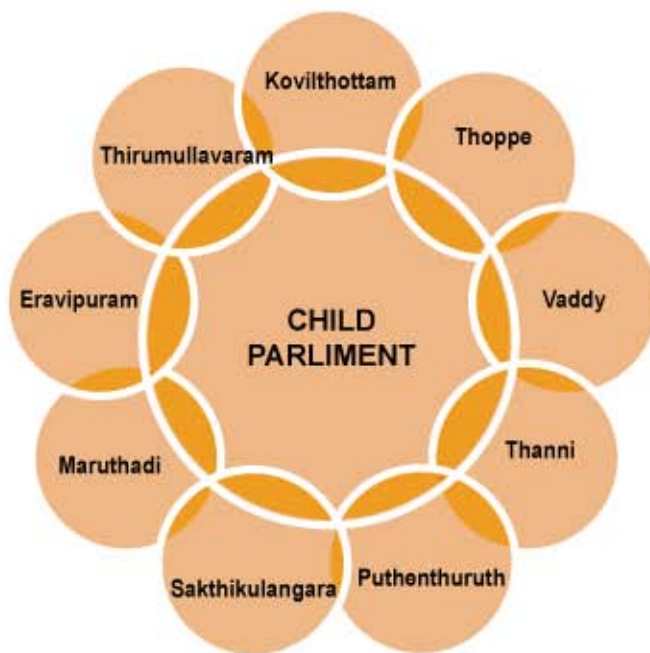


## INCLUSIVE CHILD PARLIAMENT

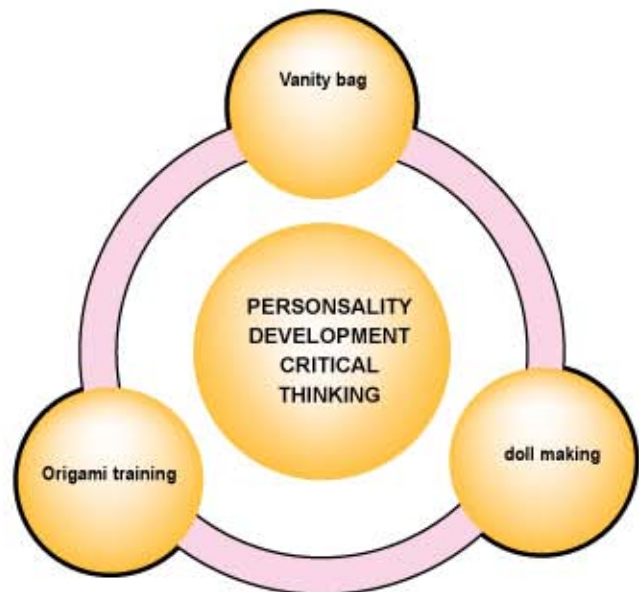

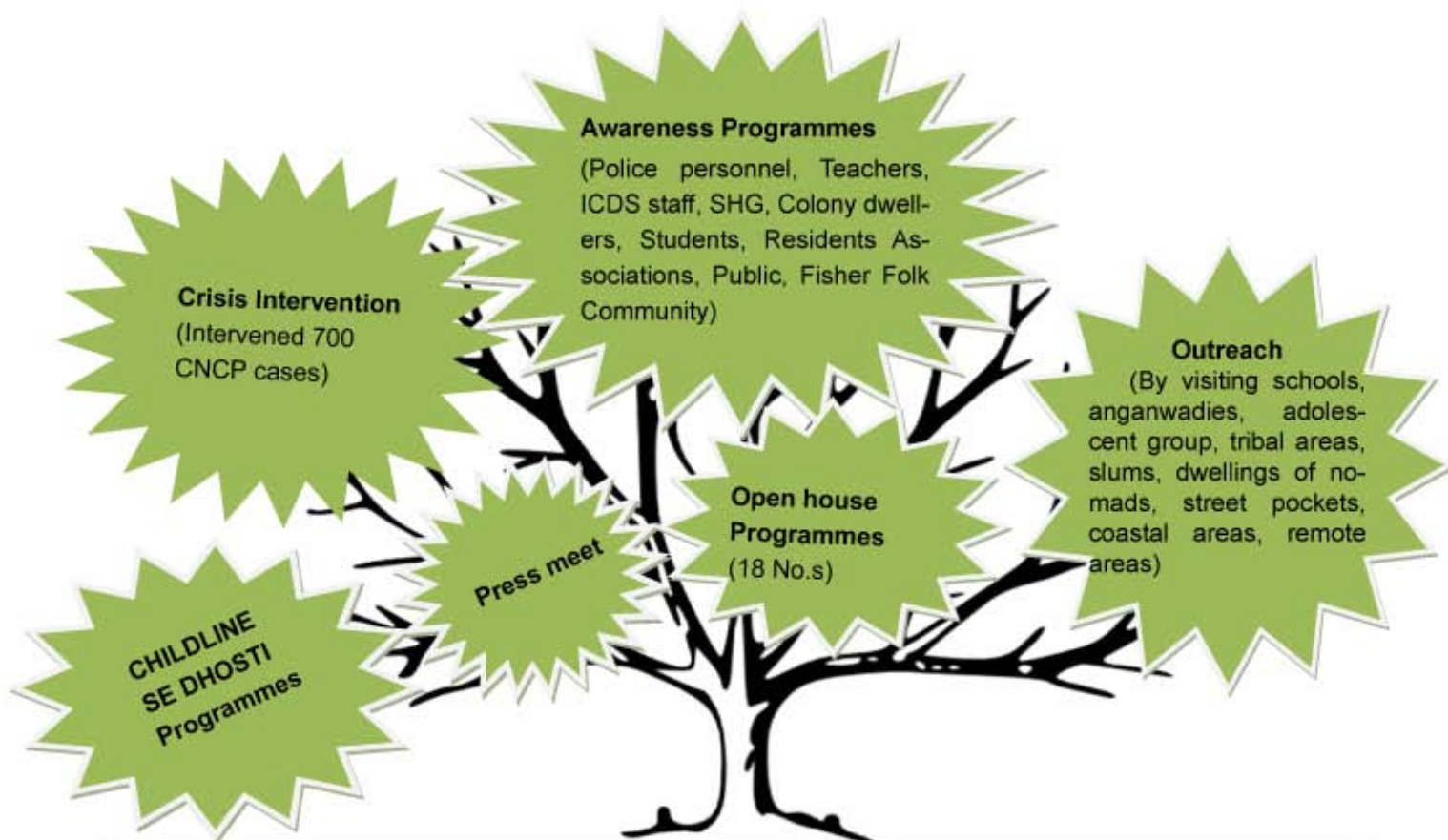


## CHILDLINE 1098

## KOLPING INDIA

Kolping India functions under the registration of public Charitable Trust since 1991 based on the shared values/ shared beliefs of Adolph Kolping with the sole aim to enhance the capacities of the poor to enjoy the fullness of life. The Regional Kolping Organization and Quilon Social Service Society have been instrumental in providing basic shelters for hundreds of homeless families, organizing livelihood support for numerous Self-Help groups, providing occupational assistance for several unemployed, especially women, and educational sponsorship for children.

## **DEPARTMENT OF HOUSING & INFRASTRUCTURE**

### **HOUSING & INFRASTRUCTURE**

The QSSS had played a very good role in the building of houses in the Tsunami affected area. QSSS had undertaken the construction of 1,028 houses at the following places. Moothakkara, Thannimukku, Sakthikulangara, Kuttikkad, Chavara, Karikuzhy and Akkolil as per GO (RT) No.1909/2008/DMD dated 7/6/2008. The Government Order was issued to QSSS on the basis of social commitment evidenced by us in the whole rehabilitation process after the Tsunami disaster in December, 2004. Thus the government decided to implement the construction of the above mentioned houses for the affected through QSSS on “no profit no loss” basis. QSSS started the work after executing MOU with the District Collector. During the year reported construction of 1094 houses were completed at Thannimukku and Kuttikkad.







## DEPARTMENT OF SOCIAL SECURITY

### KERALA LABOUR MOVEMENT (KLM)

Kerala Labour Movement (KLM) is the official organ of Kerala Catholic Bishops' (KCBC) Commission for Labour, working for the Welfare and Empowerment of the workers, especially the unorganized workers in Kerala. It has been functioning since 1972 and has the history of four decades of selfless service in the empowerment of the unorganized workers in the State. KLM reaches out to the grass root level through the diocesan networks of KLM and the networks of the workers' forums. Some of the workers, forums organized by KLM have now been registered as independent trade unions as the other trade unions in the State. KLM has been recognized as the founder member of the Workers India Federation (WIF), the national body of the different labour movements and NGO s working with unorganized labourers.





## MICRO INSURANCE

QSSS promotes micro-insurance policy among the marginalized people in the society. Life Insurance Corporation introduced JEEVAN MADHUR in October, 2007. The aim of this scheme is to extend the policy coverage to the low income group, especially those who have no fixed and stable income. The insurance can be started with a premium amount of Rs.100 - 500 for a period of 5 to 15 years. The age limit is from 18 to 60 yrs. The sum assured has a stipulated minimum of Rs. 6,000/- and maximum Rs.30,000/- . The success of this micro - insurance scheme has motivated & enabled us to increase the number of policy holders. At present we have a total of 2500 policy holders. The community organizers, the back bone, act as policy agents and collect the premium. This year 250 policy holders have completed their 5 to 7 years policy period and have received their sum of premium and interest in the form of cheques from LIC. 68 policy holders withdrew their policies before completion. Every month, training has been given to the LIC agents to implement new strategies and to increase the number of policies.



## LIC Bhagyalekshmi

Bhagyalekshmi is a new venture of LIC, started at QSSS, holding the policies of Rs.20,000 for a period of 5 years. 14 new members were added this year.

## LIC New JeevanMangal

New JeevanMangal is another insurance policy of LIC which is taken up by QSSS. This is a policy which assures the claim of Rs.10,000. The premium has to be paid for just once and it offers coverage for 10 years. 19 new members were added. There are 43 members at present.

In recent times, high tides and sea erosion has damaged various houses on the coastal line of Eravipuram, a beneficiary community of QSSS. Fisheries team and Disaster Management team of QSSS started lobbying for the affected families. They organized a protest and rally that forced the respective govt. departments to take action by placing rock adjacent to the coastal road to curtail/withstand erosion. Joint Farming, which is currently practiced in the lakes, began two units of joint farming with the help of CMFRI in Thirumullavaram as the first step to start fish farming in the sea.

The fishermen with the support of CMFRI do joint agriculture at Kochuthuruth Lake in Neendakara. CMFRI scientists' evince keen interest in this modern type of farming by giving suitable advice and technical instructions. They also help with an effective monitoring. Meetings of joint farmers of shell fish were conducted in the parish hall of Thekkumbhagam in Chavara and also in the QSSS hall. The members took the first step for the formation of producers' company.

Anjanam QSSS Children's Home (Girls) is an innovative venture in collaboration with Integrated Child Protection Scheme and NGO (QSSS) under Juvenile Justice (Care and Protection of Children) Act 2000. It was started on June 1st 2015 at Sakthikulangara in Kollam with 25 girls in the age group of 6 to 16 as per the order of Child Welfare Committee (CWC), Kollam. They are studying in classes from 1st grade to 10th grade, in St. Leon's L.P. School and St Joseph's High School, Sakthikulangara.

Currently there are 26 school-going children studying in classes ranging from 1st to 10th grade. The functioning of the Home is so far so good and it is expected to continue so.

Economically backward eligible students are studying in DB Tech, QSSS, Kollam. ABAD provides good opportunities for our students with limited qualifications. Mr. Jaya Kumar (H R Manager ABAD Hotels) and Bindu, Corporate Manager, ABAD Hotels in Kerala) conducted the interview and nearly 24 students were appeared and 17 students were selected.

These candidates have to serve one year with a stipend of Rs.6,000- per month plus food & accommodation. After successful training, they are considered for permanent jobs depending upon their performance.





## VOLUNTEERISM

QSSS has always been and is one of the top choices of colleges and educational institutions in Kollam and nearby districts who send their students for fieldwork or internship. This society has been one of the best places to experience the true essence of social work and other relevant social ideas, because of its myriad community projects and client groups. Students from various backgrounds like social work, management, law and nursing have come here for fieldwork experience. Social work students were able to relate with social work principles, practices and the functioning of NGO. 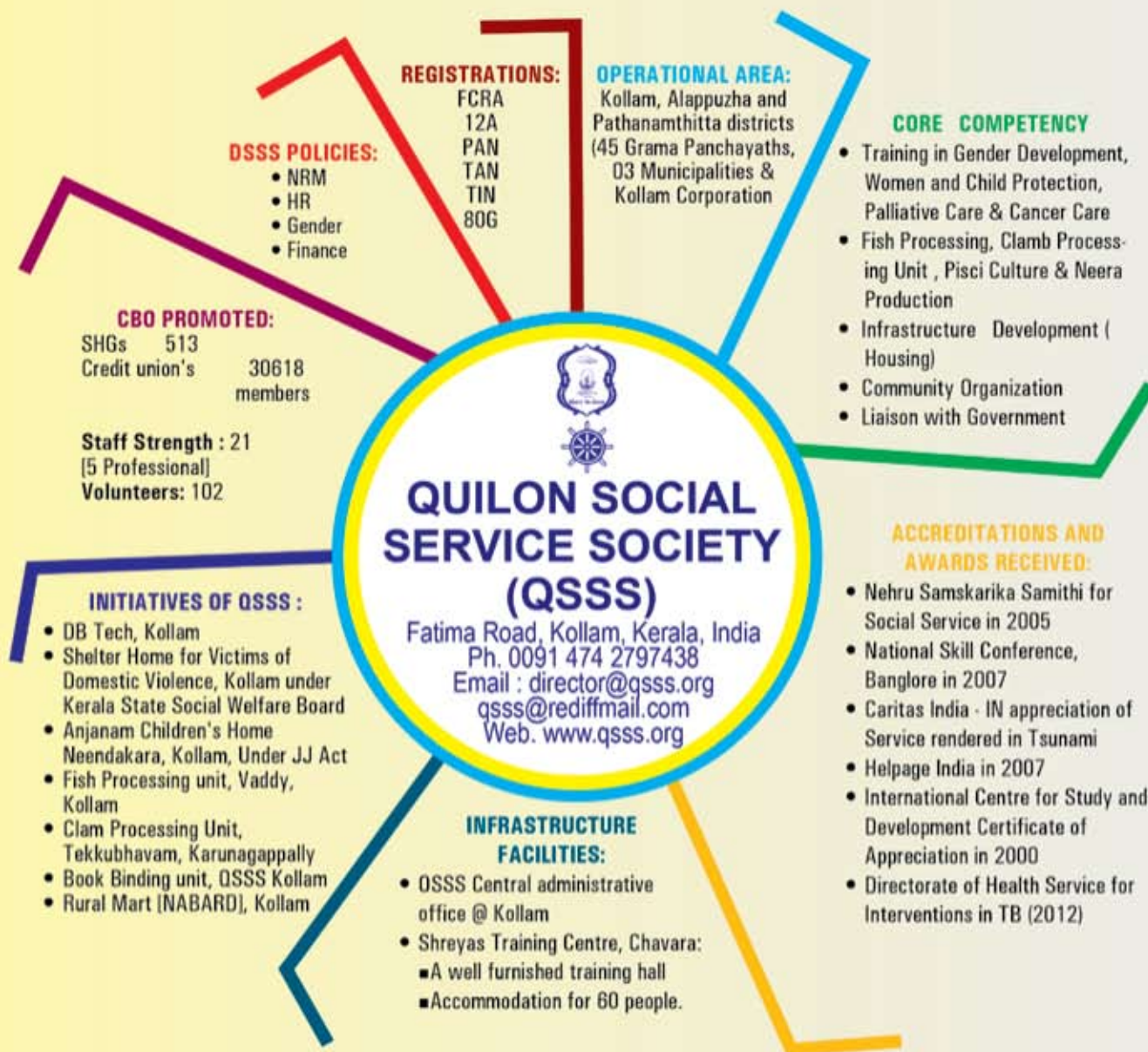
